
### **DURSA Amendment**


- A DURSA Task Group has been meeting to address the federal agencies need to comply with Controlled Unclassified Information (CUI) requirements as required by Executive Order 13556 and 32 CFR Part 2002
- We are still working through updates to the language to Section 14.02 of the DURSA Amendment and iterating on the best way to define the operational specifications required to implement CUI.
- Additional discussion is still needed and the Task Group is meeting this week.

### **Carequality Pilot**


- The eHealth Exchange will sign an updated Carequality Connected Agreement (CCA) and application to reflect our dba change.

- Target kickoff: Early 2019


