


Testing Program Reminder Didi Davis, VP, Informatics, Conformity, & Interoperability

eHealth Exchange Carequality Implementer Status

DURSA Amendment – Current Status

- DURSA Amendment changes are still being finalized as we are still addressing the Federal Participants requirement to comply with Controlled Unclassified Information (CUI) requirements as required by Executive Order 13556 and 32 CFR Part 2002
- It has been difficult to accommodate the language within the DURSA due to the nature
 of the agreement and the need for additional specificity so that Participants can
 comply.
- The CUI requirement ultimately applies to any non-federal organization that receives data from a federal agency, which will include multiple networks and frameworks.
- We need to provide time for the eHealth Exchange to initiate a collaborative process with federal and non-federal Participants to further identify and document the specific requirements needed within the network.
- We are exploring the possibility of modifying the eHealth Exchange Participation Agreement to include the CUI language rather than include this within the DURSA.

Carequality Pilot – Current Status

- We are currently in the operations planning process, which includes:
 - Participation in the Carequality workgroups
 - Reviewing and drafting/updating eHealth Exchange policies as necessary
 - Reviewing the latest CCA and CC term updates that are currently pending and finalizing the necessary addendum

eHealth Exchange Hub – Status and Outreach Activities

- Staff will reach out to Participants to begin coordination for the hub rollout.
- Requires coordination on the modified Participation Agreement and BAA
- Information we will need to know:
 - Are your Directory entries current current for both Validation & Production environments
 - Does your organization use test patients?
 - If so, for which environment (Validation, Production, or both)
 - Are they active?
