

How will TEFCA Work?




What is the Trusted Exchange Framework (TEFCA)?

It's a federally endorsed governance framework for **cross-network** exchange of healthcare records.

Similar to Carequality, it's a framework, and <u>not</u> a network:

- Technical & policy agreements
- Governing structure
- Federated architecture

Enables healthcare organizations connected to a TEFCA Qualified Health Information Network (QHIN) to exchange patient data with other healthcare organizations connected to other QHINs.



Which networks plan to exchange via TEFCA?

The HHS announced that the <u>eHealth Exchange</u> is one of six applicants that have had their applications to become a Qualified Health Information Network (QHIN) approved

eHealth Exchange QHIN: Intent to Participate


Prior to eHealth Exchange Connecting with TEFCA

Your organization can exchange with the eHealth Exchange's 320+ health systems, federal agencies, providers and provider collaboratives.



Once eHealth Exchange Goes Live on TEFCA

<u>**Option</u>** for your organization to **also** exchange with healthcare organizations participating in TEFCA QHINs.</u>

- Enforced content quality assurance
- ✓ Analytics dashboard

- ✓ Trust (no patient tracking, no selling data)

- Vendor agnostic
- ▲ 24x7x365 monitoring
- Mandatory content testing
- Analytics portal dashboard
- Broad federal agency connectivity





TEFCA QHIN Technical Readiness FAQs

What TEFCA Hub features are done and ready to test?

- 1. The TEFCA Hub supports
 - 1. Bi-directional ITI-55, 38, and 39.
 - 2. Bi-directional ITI-41/ITI-80 with transformation (TEFCA mandates ITI-80)
- 2. eHealth Exchange QHIN Directory
 - 1. Participants will be populated into once they are ready
 - 2. Participants would obtain TEFCA organization data

What TEFCA Hub features are done coming up soon?

- 1. The TEFCA Directory GUI running on top of the eHx QHIN Directory
- 2. Access will be limited, at least initially, to eHealth Exchange Staff

What notable TEFCA Hub features are <u>not</u> going to be deployed?

- 1. Candidate QHIN's must support all mandatory QHIN requirements
- 2. IAS Providers (initiating side) are optional
- 3. Initially no Participants indicate readiness to deploy IAS Providers
- 4. Several Participants have indicated IAS Provider services are on their developmental roadmaps for future deployments
- 5. Reminder: All TEFCA Participants will have to respond to both treatment and request Purposes of Use on day one

TEFCA New Purpose Of Use Open Discussion

The RCE has Proposed a New Purpose of Use (PoU) Concept

- The proposal under consideration would create a new Purpose of Use value such as "TESTING"
- Purpose is to allow for a clear delineation of those messages used for testing purposes
- This is not an existing standards-based value set and it is not based on the NHIN value set
- It would be an addition to the value set maintained by the RCE

Major Technical Differences eHealth Exchange QHIN Participants Must Support

- 1. Adopt USDCI v1 data classes and elements
- 2. Adhere to the Concise Consolidated CDA 1.1 Specification
- 3. Adhere to Project US@ patient addressing
- 4. Adopt IHE ITI Technical Framework Revisions 17.0 (versus Revision 8.0)
- 5. Accept aggregated XCPD responses
- 6. Various requirements such Purpose Of Use values, different consent attribute structure, sub-participant directory entries and detailed reporting, onboarding log submissions, specific test patients, and quarterly reporting.
